PESO has developed an online module for approval of Petroleum Refinery and commissioning permission of Refinery and revalidation of existing approved / commissioned Refinery having valid PESO permission issued by Chief Controller of Explosives (CCE), Nagpur so as to generate unique approval number and doc key no. for the respective Refinery Unit under Petroleum Rules, 2002.

To avail this facility it is essential for all entities holding approval / commissioning permission in respect of the Petroleum Refinery issued by CCE, Nagpur and new entities desiring to obtain approval for Petroleum Refinery / commissioning permission to register through the “Apply Online” → “Petroleum / Gas Cylinders / SMPV (U) Rules Application Login” link given on the PESO’s website <http://peso.gov.in/index.aspx> and create a profile with user id and password.


In this matter help guideline for the online application process is available at Login Page of the aforesaid online application with title “Help Operational Guideline for Approval of Refinery”.

Please note that the online approval / commissioning permission for Refinery and revalidation of existing Petroleum Refinery is mandatory w.e.f from **15th December**,

2017. All the existing entities are advised to avail this facility and start submitting their online applications and get their existing approved / commissioned Refinery revalidated.
