Sub: Mandatory submission of Monthly Returns by the license holders in Forms: P1, P2, P3 and P5 under Ammonium Nitrate Rules 2012 through PESO's- "Ammonium Nitrate Return System" (ANRS) application software – Reg.

Dear Sir(s),

As you are aware, that holders of Ammonium Nitrate Manufacturer/Converter/Stevedore/Store house/Import/Export Licenses in Form P1, P2, P3 and P5 under Ammonium Nitrate Rules, 2012 are required to submit monthly returns of Ammonium Nitrate in respect of manufacturing, conversion, stevedored, received, sold, used, destroyed, imported and/or exported in the forms prescribed in Part 3 of Schedule II by 10th day of every succeeding month, as per the provisions under Rule 14 (3) of aforesaid Rules.

To facilitate this, PESO has developed a web-enabled application software (ANRS) to generate daily online records through this system, in the prescribed forms i.e. R-2, R-3, R-4, R-5, R-7, R-8, R-10 (Indent), R-11(b) (Pass for Sale), and R-13 (Pass for Use) in order to generate online monthly returns in Form R-9.

For online generation and submission of the aforesaid returns on Ammonium Nitrate; every licensee needs to register the license/licenses online by visiting the sign-in-page through <http://peso.gov.in> --> **ANRS - Ammonium Nitrate Returns System, which will be available from 11th May 2015 by 11.00 am.**

A detailed Guideline Document (Tutorial) giving stepwise-procedure for online submission is also made available on the same sign-in-page. For further assistance and guidance you may send an email to support.an@explosives.gov.in and may also contact on 0712 - 2510291 / 2510873 for any clarifications.

In pursuance of Rule 14(4) of Ammonium Nitrate Rules, 2012, online submission of returns is made mandatory for all the license holders with effect from **1st June 2015**. You are therefore advised to complete the registration process and get yourself acquainted with the online system prior to 31st May, 2015.

The return data submitted in the online system till 31.05.2015 will be for trial purpose only, hence this data will not be considered for scrutiny of returns by PESO.

For the convenience of all licensees, PESO is organizing a one-day training workshop at PESO Head Office, Nagpur on **22nd May 2015 to commence from 11.00 hrs**. All license holders are therefore advised to depute their concerned officials to attend this training program.
