### Expression of Interest for empaneling Third-Party Inspecting Agency under the Static and Mobile Pressure Vessels (Unfired) Rules, 2016

Petroleum and Explosives Safety Organisation (PESO) a sub-ordinate office of Department for Promotion of Industry and Internal Trade (DPIIT) is entrusted with administration of the Explosives Act, 1884, the Petroleum Act, 1934, the Inflammable Substance Act, 1952 and Rules framed therein. Around 3,50,000 premises related to manufacturing / storage / use / transportation of Petroleum, Explosives, Compressed Gases, Ammonium Nitrate & Calcium Carbide are covered under various licenses / approval granted under aforesaid statutes.

PESO intends to empanel Third-Party Inspection Agencies (TPIA) of National & International repute to perform the work of inspection / safety audit as per provisions of the Static & Mobile Pressure Vessels (Unfired) Rules, 2016. Organisations fulfilling following minimum eligibility criteria may submit their applications for empanelment and recognition as Third-Party Inspection Agencies (TPIA).

### (A) Eligibility Criteria:

- (i) Participating TPIA shall be a professional organisation registered & located in India with minimum two or more persons.
- (ii) Minimum educational qualifications and experience of persons employed in TPIA are specified in **Annexure-I**.
- (iii) The firm should be capable of conducting, interpreting the Hazard Operability Studies, Risk & Consequence Analysis Studies and shall have adequate experience to conduct Procedural Safety Audits (Including fire safety, electrical safety, equipment safety, training of personnel to meet emergency situations, etc).
- (iv) The organisation shall not be blacklisted or debarred by Government of India. An undertaking in this regard shall be submitted.

### (B) Process of Selection:

- (i) All the applications of TPIA shall be assessed for their eligibility as per the provisions of the Static & Mobile Pressure Vessels (Unfired) Rules, 2016.
- (ii) Applicants will submit their application in a prescribed proforma
- (iii) Based on the documentary evidence on the expertise of the TPIA in specific fields, the recognition of TPIA will be considered under specific provisions of the rules.
- (iv) The disposal of the application will be done in 30 days from receipt of the application. In case of discrepancy is observed, clarification will be sought from TPIA.

(C) Important Note:

- (i) By making a submission in the selection process, all participants warrant and represent that to the best of their knowledge; their submission is original and does not contain any false information.
- (ii) The organisation should carry out the work related to inspection and testing through its employees that are recognized by PESO as competent persons under the rules. The assessment of the compliance's by TPIAs will be carried out annually through independent assessment agencies appointed for this purpose with the approval of Department for Promotion of Industry and Internal Trade (DPIIT).

(iii) At any stage of selection if PESO finds that any of the information submitted by applicant is false, his application will be rejected.

- (iv) PESO reserves the right, at its sole discretion, to cancel, terminate, and suspend the candidature of TPIA at any point of time if TPIA is unable to perform their duties satisfactorily.
- (v) The decision of PESO will be final and binding with regards to selection at all stages. Appeal against the decision of PESO should be submitted to higher authority in PESO or DPIIT.
