CIRCULAR

Sub: Guidelines for fabrication of bowzers and certification by competent persons under Petroleum Rules, 2002 – reg.

In view of the large number of complaints are being received against the delivery of HSD by bowzers and filling of HSD in jerry cans from bowzers, all the fabricators of bowzers shall fabricate a bowser of 3 - 6 KL on receipt of allotment letter of Oil Marketing Company (OMC) conveying that the applicant has been recognized by the OMC for delivering of HSD through bowser from FORM XIV / FORM XV premises under Petroleum Rules, 2002.

While fabricating a bowser, the fabricator shall ensure that GPS device is installed in the cabin of bowser which shall be linked with the dispenser and programmed in such a way that no delivery of HSD takes place at places other than geo fenced area. Details pertaining to the GPS device shall be mentioned in fabrication drawing to be submitted for grant / amendment of license.

While inspecting a bowser by a competent person for issuing a certificate under Part II of Form VIII of Petroleum Rules, 2002, shall ensure that GPS device is provided in the bowser and make & model and function of GPS shall be mentioned as Annexure to his certificate.

The relevant provisions of the Petroleum Rules, 2002 shall be complied at all the times.
