All the Cylinder Manufacturers in India (Through PESO Website only)

Sir / Madam,

To facilitate timely disposal of applications, it is proposed that with effect from 18/03/2024, filling permission issued under Rule 19 and 45 of the Gas Cylinders Rules, 2016 for the cylinders manufactured in India and proposed to be filled with compressed gas or cryogenic liquids shall be delegated to the Circle and Sub Circle Offices of PESO.

Accordingly, the cylinder manufacturers shall submit their applications online to the respective Circle and Sub Circle Offices under whose jurisdiction the cylinder manufacturing plant exists. Following additional guidelines in addition to the existing provisions of the rules may also be noted:-

- 1. All the applications shall be submitted online only. The person signing the online application shall specify his name, designation below the signature.
- 2. No offline application shall be considered.
- 3. A copy of approval and drawing issued by the O/o Chief Controller of Explosives shall be submitted along with documents for grant of filling permission.
- 4. Regarding introduction of third party for prototype and batch-wise inspection of cylinders, valve and regulators, this office Circular No. C.VIII(3)125/25/CIR/GCR dated 08/02/2024 (Copy enclosed) shall be followed.
- 5. Filling permission shall be issued only for those cylinders which are online re-validated by the O/o Chief Controller of Explosives, Nagpur.

All the applications which are received up to 17/03/2024 shall be processed by O/o Chief Controller of Explosives, Nagpur. Applications received on or after 18/03/2024 shall be delegated to the Circle and Sub Circle offices of PESO.

Filling permission for the cylinders which are approved by PESO and imported in India for use in the country or proposed to be filled with compressed gas and re-exported shall not be processed. Such cases shall be forwarded to the O/o Chief Controller of Explosives, Nagpur. The respective Head of the office shall ensure that necessary permissions in the online licensing module are assigned to the concerned officers to process the cases well in time to ensure that there is no delay in processing the cases. Cases pertaining to conversion due to change of Gas shall be dealt by HQ, Nagpur.
- 3. Shri S.S. Dhoke, Sr Technical Director, National Informatics Centre, Nagpur: The necessary amendments in the module may please be completed on or before 17/03/2024 so that Circle and Sub Circle offices can process the applications received by them.

### CIRCULAR.

Sub: Reduction in compliance burden – introduction of third party for prototype and batchwise inspection of cylinders, valve & regulators - reg.

With reference to this office circular No. CVIII(3)125/CIR/GCR dated 05/04/2021, it is clarified that where prototype testing has been carried out by BIS, the batch/lot testing shall be conducted by BIS. However, if batch/lot testing is required by the manufacturer to be conducted by TPIA's other than BIS, the manufacturer shall approach BIS to nominate/authorise TPIA for conducting batch/lot testing. After the batch/lot inspection by the said TPIAs nominated by BIS, the test certificate for the cleared lots will be issued by the certification officer of BIS in the respective BIS branch officers.

In the cases where the prototype testing has been conducted by TPIA other than BIS, the batch/lot testing shall be conducted by such TPIA's only and certificates for the cleared lots shall be issued by same TPIA.

This shall be strictly complied with by all manufacturers with immediate effect.
