It is understood that industries have requested to compensate the cost of other gases (other than Oxygen) which are produced simultaneously and vented out while manufacturing to meet the demand of excess Oxygen during Covid-19.

On scrutiny of the subject representation, I am to inform you that certain documents are necessary to examine the matter namely-

- 1. Unit wise manufacturing and storage capacities of various gases you manufacture, store and sale.
- 2. Month-wise Electrical power consumption for each unit from the period 1st January 2019 to 30th April 2020.
- 3. Month wise data for quantity of each of the gases you produced and sold during 1st Jan 2019 till 30th April 2020.
- 4. Quantity of gases you have carmarked under any contractual agreement with industries to whom you supply.
- 5. An undertaking that above data submitted are correct and you have documentary evidence which may be produced by you while any further scrutiny.

You are requested to circulate the above to your member industries and other claimant industries who intend to claim compensation. Please be informed that these documents are being called for only to examine the representation submitted by you and to forward this office remarks for consideration by appropriate competent authority.
