Sub: Withdrawal of Indian representatives/distributors for importing of gas cylinders/ valves/ regulators from the foreign manufacturers-Reg.

Dear Sir(s),

PESO has been approving the design drawings for gas cylinders of foreign gas cylinder manufacturers as per the provisions laid down under Rule 3 of Gas cylinder rules, 2016. While seeking approval /permission, the foreign manufacturers submit the requisite documents along with the name of Indian distributor appointed by them to import their cylinders from the country of origin and to market in India. PESO records the name of distributor referred by the manufacturer. The purpose of recording the distributor name is to monitor the movement of the imported cylinders in India as well as for fixing accountability and traceability incase of any untoward incident occurs. This will resolves techno legal complications during accident investigations. This process has been followed by PESO since its inception.

The selection/identification and appointment of the Indian distributor comes under the purview of the foreign cylinder manufacturer only and PESO has no role in selection of the Indian distributor. The same procedure is followed in recording an additional distributor referred by the foreign cylinder manufacturer.

Despite PESO follows due procedures, recently an existing Indian distributor has alleged that PESO has not obtained his consent while recording the second distributor name referred by the foreign manufacturer and the same was brought to the notice of higher dignitaries/authorities. PESO was wrongly implicated by the existing Indian distributor before higher dignitaries/authorities as if PESO has appointed Indian representatives of foreign cylinder manufacturers as distributors

Under the facts and circumstances mentioned above, kindly Show Cause within thirty days from the date of this letter as to why appropriate action, as deemed fit, should not be initiated against the persons/firms/companies who are creating conflict as stated above.

This is issued with the concurrence of Chief Controller of Explosives.
