Sub: Launch of Level II of Project SETT - Reg.

Sir(s),

Please refer to the meeting with explosives manufacturers held on 29/01/2021.

The Phase-I (2D bar codes on the outer packages of the explosives) of the project "**System on Explosives Tracking and Tracing**" (SETT) was launched on 01/01/2019. The phase-II (2D bar codes on the intermediate packages of the explosives) was proposed to be launched on 31/03/2020. However the launch was delayed due to outbreak of COVID-19 pandemic.

At present explosives manufacturers who have on-boarded and obtained size codes are able to make transactions of explosives in to the SETT module through Level I Barcodes for all types of explosives. All the stakeholders are advised to start on-boarding for Level-II barcodes for Class 6 Div-3 explosives and Level-III barcodes for Class 2, Class 3 & Class 6 Div 1&2 explosives. The details are as follows:



On boarding process for Level-II and Level-III shall be completed by 25/03/2021 and Phase-II of Project SETT shall be made operational with effect from 01/04/2021.
