CIRCULAR

Sub: Ban on Online Sale of Fireworks – Compliance of directives of Hon'ble Supreme of India in WP (C) 728 of 2015 - Reg.

Online Sales of Fireworks in any form has been banned by Hon'ble Supreme of India vide its interim judgement dated 23/10/2018 in WP (C) 728 of 2015. Violation of the above said directives may lead to contempt of Hon'ble court.

Recently, it has come to notice of this Organization some firms holding licence under Explosives Rules, 2008 were involving in unscrupulous activity of online sale of fireworks. Similar activity was also reported in Hon'ble High Court of Kerala vide WP (C) No. 9460 of 2023.

In case licence holder under Explosives Rules, 2008 violates above directives of Hon'ble Supreme Court of India, action towards cancellation of licence will be taken without making further reference to him.

In view of the above, it is once again advised to strictly adhere to various directives of Hon'ble Supreme Court of India in WP (C) 728 of 2015.
