Reference is invited to DPIIT, New Delhi's letter No.P-13033/36/2023-Explosives dated 02/11/2023 forwarding therewith DO letter No.S-18020/31/2022-SBM/DDWS dated 19/10/2023 received from the Secretary, Department of Drinking Water and Sanitation (DDWS), Ministry of Jalshakti and letter No.L-16020/5/2023-GP-I(E46813) dated 16/10/2023 received from Ministry of Petroleum and Natural Gas.

Taking into account of the above references and in continuation to this office Circular & Memo No.G.40(Misc)R.Min dated 10/10/2023, 09/11/2023 and 06/11/2023 respectively, it may be noted that CNG/CBG compressor package, used for filling of gas cylinders and for dispensing as automotive fuel installed in the premises covered under license FORM E&F and G of the said Rules were kept in abeyance from obtaining approval from the O/o. Chief Controller of Explosives, Nagpur up to 31/07/2024 & it is hereby extended up to 31/01/2025 subject to following conditions:-

All Ex electrical components installed in the CNG/CBG compressor shall be approved by the Chief Controller of Explosives and the approval shall be valid as on date.

2. An undertaking that all the electrical components installed in the CNG/CBG compressor are of the type approved by the Chief Controller of Explosives shall be submitted prior to grant/ amendment (if applicable) of the license as well as during inspection of the premises.
