**Examination for “Recognition of Competent Person” Under
The Static & Mobile Pressure Vessels (Unfired) Rules, 2016 and the Petroleum Rules, 2002**

Petroleum and Explosives Safety Organisation (PESO) proposes to conduct online written examination to recognize “Competent Persons” under the Static & Mobile Pressure Vessels (Unfired) Rules, 2016 and the Petroleum Rules, 2002.

In this regard, National Productivity Council (NPC) shall be conducting the online written examination for recognition of competent person. The details regarding eligibility criteria, procedure for application and schedule of examination is as follows:-

Eligibility criteria : for recognition of Competent Person under the Petroleum Rules, 2002

1	Rules 126 and 130	Degree in any branch of engineering from a recognised University or equivalent; Physically fit and mentally sound for carrying out tests and examination	Minimum experience of five years in testing, fabrication or installation or inspection of petroleum tanks or operation and maintenance of petroleum storage installations.
2	PART B of Forms VII and VIII	Degree or Diploma in any branch of engineering from a recognised University or equivalent; Physically fit and mentally sound for carrying out tests and examination	Minimum experience of five years in testing and fabrication or mounting of petroleum transport tanks and operation and maintenance of petroleum tank vehicles.
3	Rule 93 (Pipeline)	Degree in Chemical or Mechanical or Metallurgy engineering from a recognised University or equivalent; Physically fit and mentally sound for carrying out tests and examination	Minimum experience of five years in testing, fabrication or installation, maintenance of petroleum or liquefied petroleum gases or Natural Gas pipelines.

Note:-

- (1) Applicants employed in Central Government / State Government / Public Sector Undertakings shall in form their employer in writing before applying. Documentary evidence in this regard shall be uploaded along with online application.
- (2) Training period will not be considered as experience.
- (3) Candidates fulfilling the eligibility criteria need only apply.

AGE LIMIT :- Not more than 65 years.

Competent person intending to carry out the inspection and testing of mobile pressure vessels meant for transportation of flammable or toxic or corrosive gases under Rule 18 and or 19 may have required facilities for carrying out degassing, inspection and testing as stipulated in Appendix IIB at his command. In case, if he does not have his own approved degassing station, he may enter into agreement with owner of approved degassing station to undertake degassing, periodic inspection and testing of mobile pressure vessels meant for transportation of flammable/toxic/corrosive gases</p>

Note:-

- (1) Applicants employed in Central Government / State Government / Public Sector Undertakings shall in form their employer in writing before applying. Documentary evidence in this regard shall be uploaded along with online application.
- (2) Training period will not be considered as experience.
- (3) Candidates fulfilling the eligibility criteria need only apply.

AGE LIMIT :- Not more than 70 years.

EXAMINATION FEE : Rs.5000/- (Rs. Five Thousand only) per candidate. Fee once paid shall not be refundable or adjustable under any circumstances at any time.

EXAMINATION SCHEME:

Part-I	Separate ONLINE WRITTEN EXAMINATIONS consisting of 100 numbers multiple choice questions each for recognition of competent person under the Petroleum Rules, 2002 and the Static & Mobile Pressure Vessels (Unfired) Rules, 2016. Duration of examination : 180 minutes.
Part-II	Separate INTERVIEW for recognition of competent person under the Petroleum Rules, 2002 and the Static & Mobile Pressure Vessels (Unfired) Rules, 2016. Only those candidates who have successfully cleared the online written examination shall qualify for the interview. The qualified candidates shall be informed the interview schedule by National Productivity Council. The list of qualified candidates will be published on PESO's website.
Weightage for selection	Part-I : Online Written Examination : 60% Part-II : Interview : 40%

Schedule for written examination

The date, time and examination centres shall be communicated by National Productivity Council to the eligible candidates.

Examination Centres :

Twenty five (25) cities namely Patna, Kolkata, Bhubaneswar, Guwahati, Kanpur, Delhi, Jaipur, Chandigarh, Baroda, Mumbai, Hyderabad, Bangalore, Chennai, Imphal, Shillong, Port Blair, Jammu, Nagpur, Bhopal, Raipur, Ranchi, Kochi, Visakhapatnam, Indore and Dehradun.

Note : National Productivity Council reserves right to allocate the examination centre depending upon number of candidates opted for a particular examination centre.

1. Covering letter providing details of each candidate proposed to be recognized as competent person.
2. Signed copy of online application FORM as applicable. The person signing the application FORM shall specify his name and designation below the signature with official seal if any.
3. Educational qualifications in respect of each candidate. Mark sheets of 10th, 12th Class and Diploma or Bachelors Degree in Engineering as per above said eligibility criteria.
4. Experience certificate in the relevant fields of each candidate as specified above. The experience certificate shall be duly vetted by the employer. The employer signing the experience certificate shall specify his name and designation below the signature.
5. Certified copy of letter from the present employer as applicable to be submitted.
6. Aadhar Card or PAN Card or 10th Mark sheet as a proof for date of birth.
7. Fitness certificate of each candidate issued by the medical officer of Government Hospital only shall be considered.
8. Signed copy of colour passport size photograph of each candidate in jpg / jpeg format with good resolution.
