Sub: Online Generation of Form RE-12 [Transport of Explosives] through the PESO's Online Quarterly/Monthly Returns Software by LE-3 license holders – Reg.

Sir(s),

As required under the provisions of Rule 24 of Explosives Rules, 2008, holders of Licence in From LE-3, for "possession & sale" and "possession & use" under Explosives Rule 2008 are submitting Quarterly Returns (RE-7), through the PESO's Online Quarterly Returns Software.

The additional facility of online generation of RE-12 [Transport of Explosives] has been created. The holders of Licence in From LE-3, for "possession & sale" and "possession & use" are advised to start using this facility with effect from 1st July, 2011.

The said facility can be accessed by using the same login ID / User ID created for each license. The RE-12 has to be generated before doing the sales transaction entry for magazine. This will enable automatic entry of sales in the Quarterly Returns of respective magazine. The copies of RE-12 to be forwarded to various agencies can also be printed.
