PESO has already developed an online module for approval of laying and commissioning of cross-country pipelines and revalidation of existing approved/commissioned cross-country pipelines having valid PESO permission issued by Chief Controller of Explosives (CCE), Nagpur so as to generate unique approval number and dokey for the respective cross-country pipelines under Petroleum Rules, 2002/MSIHC Rules, 1989. This office letter of even no. dated 24.08.2017 may be referred in this regard.

To avail this facility, it is essential for all entities holding approval/commissioning permission in respect of the cross-country pipelines issued by CCE, Nagpur and new entities desiring to obtain approval for laying of pipelines/commissioning permission to register through the "Apply Online" → "Petroleum/ Gas Cylinders/ SMPV(U) Rules Application Login" link given on the PESO's website <http://peso.gov.in/index.aspx> and create a profile with user id and password. In this matter held guideline for the online application process is available at Login Page of the aforesaid online application with title "Help Operational Guideline for Pipeline Approval".

Please note that the online approval for laying/commissioning permission for cross-country pipelines and revalidation of existing cross-country pipeline is mandatory w.e.f. 1st October 2019. All the existing entities are advised to avail this facility and submit their online applications and get their existing approved/commissioned cross-country pipelines revalidated on priority.
